Rear Garden:

Oak: Approximately 22m. Condition fair/good. This splendid mature oak has been heavily pruned recently. The heavy crown reduction has led to fast and weak epicormic/ reactionary re-growth throughout the crown. At this juncture we wish to apply to remove dead wood and broken branches, thin crown density throughout by 20-25% by means of selectively removing epicormic growth throughout the crown whilst retaining strong viable epicormic growth where it would add to the future healthy crown structure. Crown thin branch extremities by 20%. Remove dead ivy and stub ended cuts.

Reasons: To promote strong balanced and healthy crown structure, increase light levels to surrounding properties, reduce potential hazards and wind resistance, reduce leaf area and help curtail tree's sphere of influence whilst preserving and enhancing the tree's natural characteristics and aesthetic value.
