Robinia Pseudoacacia - thin by 30% and cut back to previous reduction points. The reason for the work is the tree is less than a meter from my house and has grown quickly since it was last pruned and now overhangs the roof and gutters.

Wild Damson - thin and cut back by 30%. I do not believe this tree has ever been pruned. It has now grown out of proportion to its location and would benefit significantly from being pruned and shaped.
