## Informative(s):

1 You are advised that all conditions relating to the above mentioned listed building consent which need details to be submitted, have been approved.



2 The approval of details application is a response to a condition in 2014/6748/L, namely:

Samples of materials in respect of the following, shall be submitted to and approved in writing by the local planning authority before the relevant part of the work is begun:

- a) Typical sample of timber to be used for the doorway.
- b) Sample of proposed steelwork within the doorway and canopy to show colouration and detailing.
- c) Sample of proposed glazing.

The applicant has displayed a door segment, doorway canopy and glass sample to comply with conditions 2a, b and c of 2014/6748/L.

The glass is clear and thick. The door sample is of high-quality timber. The canopy is of black-painted metal and glass and is designed to blend in with the overall aesthetic of the host building while being differentiated, to indicate their non-original status. The glass can be removed for cleaning, while the whole is drained by a flat, slimline pipe mounted flush in the reveal to one side of the doorway.

There will be no loss of or harmful impact upon historic fabric. The proposal is therefore considered to preserve the special architectural and historic interest of the listed building.

A site notice and press notice were posted, but no responses were received.

The site's planning history was taken into account when coming to this decision.

Special regard has been attached to the desirability of preserving the listed building or its setting or any features of special architectural or historic interest which it possesses, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with policy CS14 of the London Borough of Camden Local Development Framework Core Strategy, and policy DP25 of the London Borough of Camden Local Development Framework Development Policies. The proposed development also accords with policy 7.8 of the London Plan 2011, and paragraphs 14, 17 and 126-141 of the National Planning Policy Framework.
