  - In my capacity as previous freehold proprietor and my ongoing responsibility for its management I have detailed knowledge of the Property spanning a continuous period of 28 years
  - 4. The basement and ground floor of the Property was arranged as one non-self contained residential unit on the date of acquisition
  - During the period June 2001 to November 2001 works were undertaken to convert the basement and ground floor flat into four self-contained residential units
- 6. From November 2001 to the present the layout of the basement and ground floors has been maintained without alterations
- 7. The basement floor comprises Flat 1 (a one bedroom unit) and Flat 2 (a one bedroom unit) configured as shown on floor plan ref: 1505.1 dated 15 April 2015

- 8. The ground floor comprises Flat 3 (a one bedroom unit) and Flat 4 (a one bedroom unit) configured as shown on floor plan reference: 1505.1 dated 15 April 2015
- 9. The units have been let to residents on the basis of assured shorthold tenancy agreements since November 2001 to the present date
- 10. The four flats have been used as self-contained dwellings and for no other purpose
- 11.Flat 1 has been continuously occupied since 16 November 2009 to the present date save for periods totalling less than 3 weeks between residential tenants
- 12. Flat 2 has been occupied since 1 October 2009 to the present date save for a period totalling less than four weeks between residential tenants
- 13. Flat 3 has been continuously occupied by a single household since 4 November 2009 to the present date save for a period totalling less than two weeks between residential tenants
- 14. Flat 4 has been continuously occupied by a single household since 1 July 2009 to the present date save for a period of less than three weeks between residential tenants
