2014/6808/P	11 Hampstead Square, NW3 1AB	Planning permission is sought for replacement of one sash window at lower ground level on the rear elevation with timber french doors, removal of a steel external staircase providing access to french windows at upper ground floor, and addition of a steel Juliet balcony railing to retained french windows at upper ground level.
2014/6700/P	26 Denning Road, NW3 1SU	Creation of basement by increasing depth of existing sub-basement floor level.
2015/0315/P	4 Langland Gardens NW3 6PY	Erection of a single storey rear extension at ground floor level, the installation of balustrade with side screening for a terrace at first floor and installation balustrade with planters for a terrace at roof level and erection of a dormer extension to the side elevation.
2015/0057/P	64 Belsize Park Gardens, NW3 4NE	Erection of single storey glazed rear extension to lower ground floor level flat.
