We are a residential community of more than 300 people, within 100 metres of this proposal</p> <p>Camden is spending millions of pounds on improving the public realm around Tottenham Court Road and surrounding streets. Is this application appropriate in light of that?</p> <p>Is it appropriate in light of the surrounding residential area?</p> <p>Is it appropriate that the additional transport links that are to be on our doorstep will be so gaudily lit to make any calmness gone?...This will only lead to more drunkenness and drug use in the area at night. There is simply no cohesive plan at the St Giles, each little spot being used in turn to make squeeze every penny possible out of the site, with absolutely no regard for the local area.</p> <p>Do you really think it is appropriate for this area to become a second Piccadilly Circus?</p> <p>It is simply not appropriate with such a large residential community yards away, as well as being adjacent to Bloomsbury Conservation area.</p> <p>Time and time again we have commented on the over commercialisation of the St Giles Hotel site and its extended businesses, that are carried with scant regard for the neighbours and local residents. Usually being done in advance before any permissions, or by playing the system and the various departments of Camden to get its on way..and when it doesn't and it seems to have total impunity from any enforcement by Camden and its officers.</p> <p>This is yet another example.</p> <p>WHY is this being dealt with under delegated powers to a single officer.?</p> <p>Why is it in a 'Fast Track' department?</p> <p>This is a MAJOR change to the area , one that should be consider at committee level involving the elected councillors.</p> <p>Please ensure this application is REFUSED</p>
