Jennifer,

It has been several months since we last spoke about the extension to 16 Chilly Cool. Please could you give me an update on their retrospective planning application?

As I have outlined previously, the recent rear extension is very poor quality. It forms a full width rear extension with the previous rear extensions, making access to the oversized ventilation ducts unnecessarily difficult / dangerous. This is obviously in the context of the Grade II Listed Georgian terrace.

Work is still on-going internally and the noisy extract fan is often running late into the night. On Monday night I was shouting through the shop front at 3.30am in the morning trying to get them to stop working and turn the extract off! This clearly isn't acceptable and I would really like to know what will be done about it!

Furthermore, two wheelie bins have been placed in front of the restaurant . When I enquired about these a week ago they said that they were only temporary to get them through the Bank Holiday weekend, but clearly they were not. I did not buy a flat with wheelie bins next to the front door, and fell that it is unreasonable to have to put up with this. The fact that Chilly Cool has expanded over number 15 & 16, means that they produce more waste, and need to form a clear waste and resulting strategy like other restaurants throughout the city.

I look forward to hearing back from you at you earliest opportunity.


Dear Jennifer,
