Minor amendments are proposed to the approved scheme, therefore the drawings numbers approved and listed under Condition 3 would need to be updated. Proposed amendments as follows:

- Rear terrace at third floor as approved enclosed with a glazed roof to create an internal winter garden. Associated changes to rear elevation at third floor to create a window with high level opening vents and building up shared wall with No. 10 slightly to allow head height for glass roof.
- Two roof lights as approved the to third floor flat roof revised to one glazed automatic smoke vent.
- Additional window in rear elevation at second floor for shower room.
- Fixed window at first floor landing revised to be opening for ventilation and cleaning.
