Thank you very much for your email.

Please find a pdf with the drawings you requested attached. These are mostly typical manufacturer details and not to scale. Should you require drawings in 1:20 I can draw them up but I believe the info attached might be sufficient.

List of the drawings/information attached:

1a. Section through Fascia sign – typical manufacturer detail

The fascia is manufactured in aluminium and has purple finish. At the bottom there is a red stripe (lens) which is backlit by red LEDs.

1b. Internally mounted Chevron sign – typical manufacturer detail

These are installed behind the glazing and have internal white LED illumination as shown on drawing.

1c. Face illuminated lettering on Fascia – typical manufacturer detail

All the letters including the chevron sign will be face illuminated as per drawings.

1d. Internally illuminated hanging signs – typical manufacturer detail

These are internally illuminated by LEDs (LED sheet) and a red led strip as per drawings.

1e. Internally suspended light pocket – photos

These will be internally mounted behind the glazing.
