On top of the existing wall there is a rusty iron fence, and the pedestrian entrance to the site has an iron gate. On one side of the property there is an iron fence separating the boundary between 57 and 55 Ravenshaw Street

All iron to be removed and replaced with white picket style fencing and gate. Boundaries to both 55 and 59 Ravenshaw street will be separated by white picket fencing.

Main hard standing is currently concrete with a layer of shingle over an area. There is a raised section of brick and slate, and another raised area on the same level of brick encasing some earth where a bush is growing.
