The current building is a student residential building belonging to University college london. The heating and hot water system is being refurbished with new plant replacing the existing plant within the fully enclosed basement level plant room. the new plant being installed will be fully internal and have similar characteristics as the existing plant therefore there will be no acoustic iimpact on the space.

there will be a requirement for a new flue of approximate 350mm diameter to exit the existing basement level plant room through a new builders work opening in the concrete wall. it is proposed to run the new boiler flue up the facade of the building from high level basement to terminate at roof level. this route is illustrated on the attached drawings.

The new boilers are 3No. Remeha Gas Eco Pro 310-355 boilers. the details of these boilers including NOx emmissions and flue details have been included in the attached documents.
