Rear Garden:

Twin Stemmed Sycamore: Approximately 21m. Tree is situated in 9 Upper Park Road. This tree is heavily shading both properties. Thin crown density by 25-30%. Remove dead wood. Remove ivy from stem closest to 9 Upper Park Road. Raise crown over 9 Upper Park Road by approximately 4m.

Reasons: to increase light levels and help abate nuisance whilst preserving tree's natural characteristics and aesthetic value.
