Within the Mansfield Bowling Club land and along the back fences of the properties at 40 to 48 York Rise there are large trees that are overshadowing the properties in York Rise.

The largest of the trees behind 42 York Rise was originally kept pollard tree, but with the demise of the Club the tree has been allowed to grow out of proportion and now dominates and overshadows everything in area - intention is to pollard it back to its original controlled size.

The tree behind 48 York Rise is relatively young but starting to get out of control and needs pollard work before it too overshadows all its vicinity.

The best approach is a visit from the Council Private Tree staff to ascertain the level of pollarding that can be undertaken to preserve the benefit of the trees but also provide access to sunlight
