Supplementary Comments

There are a number of Thames Water assets running in close proximity to the proposed
development site. Therefore, the condition cannot be discharged until all parties are satisfied that
there is negligible impact to Thames Water assets. From the Phase 2 piling layout plan
submitted, it is not possible to confirm the proposed positions of the piles in relation to these
assets. Please submit a revised piling layout plan indicating the positions of the piles in relation to
Thames Water assets and the local topography so that we can ensure the correct exclusions
