Tree is (I understand from the gardener) a sweet chestnut. It was not a planned tree, but is the result of self-seeding many years ago. The tree is now large (estimate over 12 foot). West Heath Lodge Residents Association Limited wishes to remove the entire tree because it is choking an old Mulberry Tree which is immediately adjacent to it. The condition of the Mulberry is deteriorating because of the presence of the chestnut.
