There was a minor discrepancy in the original drawings submitted to planning which incorrectly recorded the width of the existing ground floor storage room (a difference of about 55cm). This error was repeated in the drawings for the proposed first floor back extension which is being built above the storage room. In consequence, the Delegate report shows the width of the new room being 2.7 mt. The existing ground floor room is in reality 3.25 m and the proposal has always been that the new room on the first floor should have the same width as the existing ground floor storage room (as shown in the existing and proposed drawings)
