T1 Sycamore x 2 Large, mature trees. Both of these trees have decaying wounds on the Western side.

These wounds are indicative of fire damage from a barbecue. The Northernmost tree has the larger wound which has decayed deeper into the main stem. The wound wood formation is quite large, suggesting the wounds have been there for some time. To reduce the mechanical loading on the trees and to maximise light, the suggested works are: To reduce the overall height and the lateral spread all round by 3-3.5m, clean out crown, remove creeper and deadwood.
