Planning Application Details

1.2.3 Edge protection will be introduced to the main roof areas for maintenance purposes. This will incorporate an angled galvanised freestanding handrail system to a height of 1100mm.

A. I am deeply disturbed by the addition of the proposal of Edge Protection to the Roof to the proposed works to this block of flats. There has been absolutely no consultation with residents about this proposal.

Please note that I object strongly to this new proposal on the following grounds:

- It will look very ugly as because it will be made from cheap materials and it will be over a metre high and therefore visible from the street and from the roof gardens at the back.
- 2) The erection of this Edge Protection would contravene the aesthetic and architectural integrity of the building.
- 3) There is no reason to have a perimeter fence on the roof at all.

Other identical blocks in Camden do not have the addition of this unsightly fence, which will also increase the height of the block by over 1 metre and create a distorted image of the building from the road..

- 4) Camden has had no discussion with residents whatsoever about this proposed work.
- 1.2.2 The existing painted metal post and tensioned wire edge protection surrounding the glazed roof areas will be replaced with new 1100mm high stainless steel and tensioned wire rope edge protection, to be in line with the current building regulations. â*
- B. I have strong objections to the replacement of the existing harmonious painted metal posts and tensioned wire protection with unsightly stainless steel posts and far more tensioned wires than are needed for protection.
- 1) Why is this improvement not being done on a like for like basis?
