Gleditsia: Approximately 13m. Fell to ground level. This tree is poorly situated having been planted close to a retaining wall next to parking area. Some root disturbance of tarmac drive and surrounding area is present and it is fair to assume the gleditsia will continue to undermine the drive and parking area. This is an inappropriate species for the confined planting area.
