Rear Garden:  
Robinia: Approximately 16m. Fell to as near to ground level as is practicable and treat with systemic herbicide. Reasons: This tree is in very close proximity to boundary wall and crown growth overshadows several other fine trees. This tree has poor form.  
Sycamore. Located on rear boundary. Ivy Clad. Approximately 16m. Fell to ground level and treat with systemic herbicide. Reasons: Upon brief inspection of this tree, a basal cavity was discovered. The longitudinal cavity and resulting callus appear to be extensive. It is likely that the basal decay will continue and may in the future pose a significant hazard.

Front Garden  
Malus Cultivar: Located in 55 Compayne Gardens and overhanging drive. Reduce whole crown by approximately 20-25%. Reasons: to help abate nuisance, increase light levels and help curtail tree's sphere of influence in relation to walls and buildings whilst preserving the tree's natural characteristics and aesthetic value
