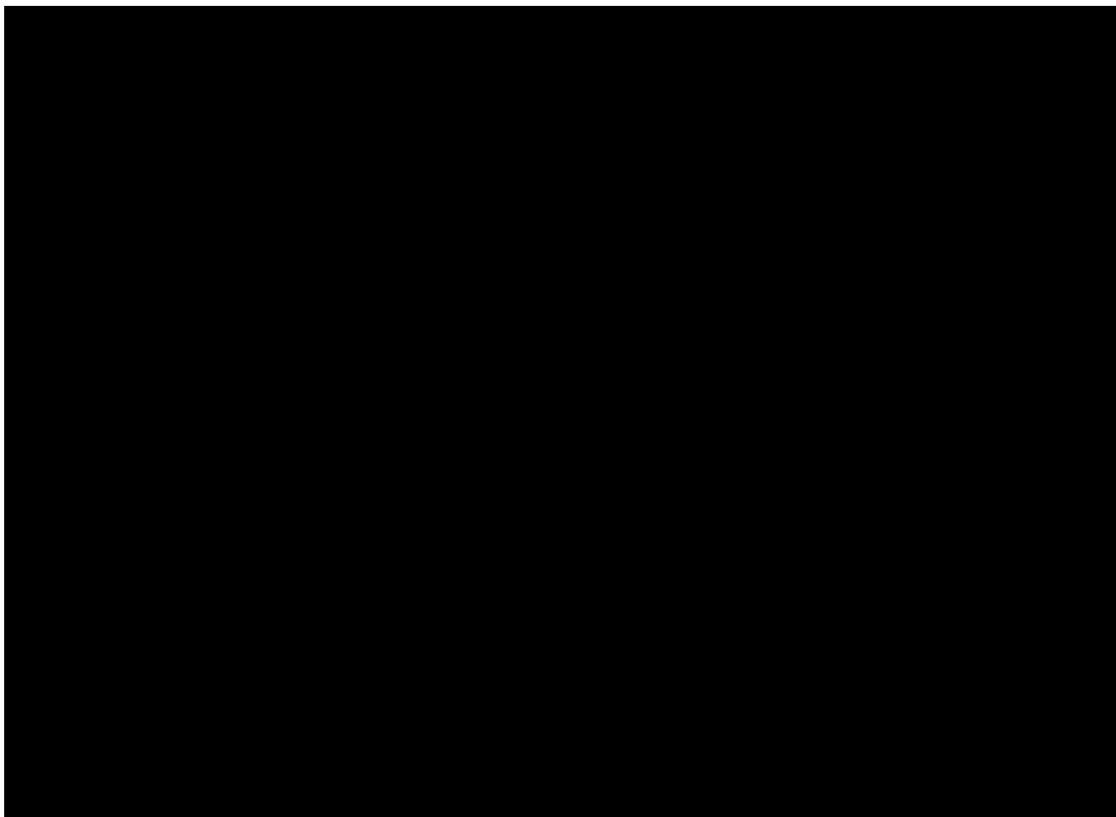

Further to our telephone conversation today regarding application 2015/3380/P for 8 Chesterford Gardens I enclose two photos. One is from the boundary between the properties and the other further back into my mother, Lady Feldman's garden who lives at 14 Greenaway Gardens NW3 7DH. I enclose a plan with her property marked.

She would like to see some screening between her garden and the applicant's with high trellis, plants / tree screening which will reduce the impact of the new terrace and staircase on her property. The applicant's property is at a much higher level and will look down into her garden if the overlooking isn't reduced in this way.

She is very concerned about the noise of construction and would hope that no building work will occur on the weekends during the summer/ autumn. My mother and father are both elderly & both sit out in the area adjacent and would hope that their peace isn't disturbed then. Development during the winter months would be much preferred when they are less likely to be sitting out.

My mothers garden is easily viewable from the rear of 8 Chesterford and so there is no there is no need for Planning Officer visit to her property.
