Olive Tree (T3)	Rear Garden Rear Boundary	Crown reduce by removing 1m from height to obtain and clear obstruction to satellite dish
Cut Leaved Sumach (T4)	Growing through fence into alleyway	Fell as close to trees current ground level as possible and leave stump in ground and treat with glyphosate to prevent regrowth
Blackberry & Various (G1)	Growing through fence into alleyway	Trim to tidy and remove obstruction through alleyway
