When does temporary become permanent?</p> <p>They obviously have no intention of complying with Condition 1 or indeed, Informative 1 of the last decision which clearly states: That they should have been seeking alternative premises. This was backed up by the major building works that were carried out in March of this year. This was highlighted to the Planning Department on the 24th March 2015.</p> <p>Is it not time that people came clean on this issue?</p> <p>Is Camden Council going to allow a Mosque to evolve in a mid-terrace building surrounded by residential properties above, to the left, to the right and behind the area involved ?</p> <p>I don't believe that any of the Conditions have truly been met in the last decision. Only yesterday cars were driven on the pavement to park in front of the building. Constant reporting of transgressions was withheld as the 30th July 2015 was approaching and it was assumed that the building would revert to normal commercial use as per all others in the area.</p> <p>My original objection still stands as follows: I would like to voice my concern around the above application. My main concern is a noise issue. The building is mid terrace with commercial units either side and domestic accommodation above and to both sides. My flat is at the rear to the side and above and I feel that the noise generated by large groups of people gathering would be too much. The soundproofing of the 100 year old building is insufficient. They have been meeting there, already, for sometime, at various hours of the day and I do hear them but have not wished to make an issue of it so far. In my mind these buildings were not designed for community use due to the closeness of private dwellings. Even 12 months could cause a serious environmental issue.</p> <p>No doubt there will be many supporting statements made by people who do not actually live here and only want it granted for their own benefit and are not concerned about the people it may affect.</p> <p>I have been resident in my building for 23 years with no major issues in that time. However, I now feel my quality of life is being threatened by this facility.</p> |
