






4 Natural Ground Subsidence 4.1 Shrink-Swell Clay Map






4.2 Landslides Map






4.3 Ground Dissolution Soluble Rocks Map






4.4 Compressible Deposits Map









 - loss of anticipated savings; (iv)
 - (v) loss of goods;
 - loss of contract; (vi)
 - loss of use; (vii)
 - (viii) loss or corruption of data or information;
 - (ix) business interruption;
- (x) any kind of special, indirect, consequential or pure economic loss, costs, damages, charges or expenses;
- loss or damage that arise as a result of the use of all or (xi) part of the Groundsure Materials in breach of the Contract;
- loss or damage arising as a result of any error, omission or inaccuracy in any part of the Groundsure Materials where such error, omission or inaccuracy is caused by any Third Party Content or any reasonable interpretation of Third Party Content;
- loss or damage to a computer, software, modem, (xiii) telephone or other property; and




