Pupils without their mobiles or a flat battery are able to contact parents using the public phone reverse charge facility. The box outside Waterlow park, the subject of this application, is opposite a Girl's school. Removal of the phone would be permanent and rob those users of a potentially important method of communication The boxes are a British icon and I feel that the installation of illuminated signage would have a significant impact on the appearance of the listed structure and the Conservation area. The simple lines, carefully considered design and overall aesthetic concept of the kiosk which embodies so much of its value as a heritage asset would be unacceptably adulterated and diminished by the incongruous introduction of the visual clutter of advertising in the first instance and an LCD display to present the advertising. The proposal is therefore considered to be contrary to Section 16(2) of the Planning [Listed Buildings and Conservation Areas] Act 1990 and paragraphs 131, 132, 133 od the National Planning Policy Framework.
