Please state why you wish the condition(s) to be removed or changed: To allow for minor material amendments to the approved scheme including a widened rear dormer, the omission of rear roof lights, the incorporation of an additional roof light on the front elevation, and revised doors on the ground floor rear elevation. The revised rear dormer will be no closer to the ridge and eaves lines than the approved structure, and its width and position on the roof will relate entirely satisfactorily to the arrangement and hierarchy of the windows below. The additional roof light on the front elevation will be of the same size and style of those previously approved. The minor changes to the doors on the ground floor rear elevation will not be visible from outside the site, and are considered to be entirely acceptable in design terms.
