T1 Bay... Large, mature tree with large root suckers. This tree is in close proximity to the drains and to properties. The almost aggressive nature of the root and trunk expansion of this species of tree will cause structural problems for the properties and it is the likely cause of the drain problems. The proximity to properties and the size of the tree means that it can't be removed in one go, as this could lead to soil heave and structural damage. The tree will need to be removed in stages over successive summers. This is to allow the soil to acclimatise to the excess moisture in the drier months. The suggested works are: To remove the twelve large root suckers, reduce the overall height of the tree by 3.5m, reduce the lateral spread all round by 2.5m, clean out crown, remove deadwood.
