1 Reasons for granting permission.

The applicant has provided a letter of appointment from Vincent & Rymill Consulting Civil & Structural Engineers who has been instructed to act as consulting engineers for the proposed basement development and will be responsible for the design and construction detailing of the temporary and permanent basement works. Vincent and Rymill will also undertake periodic site supervision and checking of the works and this person would have the necessary qualifications required by CPG 4 (Basements) of the Council's Supplementary

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area under s.72 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such the proposed development is in general accordance with policy CS5 and CS14 of the London Borough of Camden Local Development Framework Core Strategy and policies DP24, DP25, DP26 and DP27 of the London Borough of Camden Local Development Framework. The proposal also accords with policy 7.8 of the London Plan March 2015, consolidated with alterations since 2011 and paragraphs 56-68 and 126-141 of the National Planning Policy Framework.

2 You are advised that condition 4 (basement structure shall be designed and constructed in accordance with the recommendations, methodologies and mitigation measures set out in the Basement Impact Assessment hereby approved) of planning permission 2014/4824/P dated 06/10/2014 is outstanding and requires the compliance certified by the appointed structural engineer.

In dealing with the application, the Council has sought to work with the applicant in a positive and proactive way in accordance with paragraphs 186 and 187 of the National Planning Policy Framework.
