Removal of Great Hall maple floor and replacement oak floor incorporating replacement existing dais and under floor heating. Removal of Great Hall perimeter heating. Internal works to refurbish and upgrade existing basement kitchen. Basement damp proofing works. Upgrading of external and internal lighting. Replacement catering facilities. Other internal alterations. Removal of lime tree to reinstate original entrance to the Great Hall.
