Excavation underneath East Terrace to create two storey subterranean development to provide education and training floorspace ancillary to the Inn (sui generis). Proposals include 10 flexible advocacy training rooms, a 150 seat lecture theatre and associated breakout space. Connections for access to the Great Hall and library buildings. Installation of lift serving Great Hall south vestibule. New southern entrance door and removal of external northern stairs to create fire escape. Internal alterations at basement level. Provision of 10 cycle parking spaces and 2 disabled car parking spaces. Removal of two magnolia trees. Creation of attenuation soakaway. Associated landscaping. Removal of Plant in existing lightwells. Replacement external lighting in lightwells located along the East Terrace. Creation of roof lights over existing East Terrace lightwells and creation of East Terrace roof light within stone upstand. Creation of roof light within Benchers' Border. (Application 3)
