An enquiry has been made to our team in relation to the installation of advertisements to the front and rear of the kiosk without advertisement consent.

Having carried out a background check, the advertisement consent (reference: 2007/2869/A), which was granted seven years ago does not form part of a consent for the two adverts that are currently installed on the kiosk. If there was ever consent granted for the current adverts please can you provide the application reference number or send me a copy of the decision notice. Please can you submit this information within 14 days of receiving this letter.

Without prejudice, the current advertisements are unacceptable by reason of:

1. The advertisement on both side are not purpose-designed, and therefore do not accord with the Council's planning policies and regulations; and
2. do not benefit from advertisement consent.

For the purpose of managing both the Council's and your expectations, I request that the signs be removed, as it is unlikely that consent will be granted for the adverts. Please can you carry out this request with 14 days of receipt of this letter where evidence of consent cannot be submitted.

Please note that noncompliance with my request can lead to Enforcement action. This may result in the service of an enforcement notice; failure to comply can lead to prosecution.
