2015/1185/P	1a Well Road, NW3 1LJ	Replacement of existing single glazed painted timber sash and casement windows with hardwood double glazed sash and casement windows to the front facade and alterations to the front door to include addition of an over light.

Phase 2 amendments: Block J–terrace at level -02, extension of basement and amendments to windows and recesses, Block K–basement reduced in size and relocated (from under K1 to K2), alterations to elevations of K1 and K2, distance between K1 and K2 increased to 1.8m, enlargement of Block K by 80sqm, alteration to internal layout, Blocks L and M–amendments to elevations, Block M moved 300mm back from Kidderpore Avenue and removal of trees T21, T24, T25, T30, T31, T37, T38, T58, T64, T68.
