### 3. Description of the Proposal

The existing stone balustrade and handrails to either side are too low and non-compliant. The proposals are to install a galvanised steel handrail as per the attached drawings which will be painted black.  
 Remove 100% of rendered finishes to the façade and shelter, apply a new tanking system to prevent damp penetration, and reinstate rendered finishes to match existing.  
 Lift existing gravel/tarmac flooring finishes directly above the shelter to expose the substrate. Thereafter applying liquid waterproofing system before reinstating gravel/tarmac finishes to match existing.  
 Fabricate and install new balustrade and railings to the 2no. stairs either side of the shelter and landing above. The replacement balustrade is proposed to be fabricated from galvanised steel box section, painted in black gloss, to be compliant with Parts K & M of the building regulations. This will be fixed to the existing coping stones in a similar manner to the existing, and be located behind the decorative stone balustrade which is located above the shelter.  
 Localised repair and repointing of existing stone steps.
