2. Lime - Reduce back to positions close to the previous reduction points. Maximum cut size 60mm Leave as many side shoots or buds, as possible, and a natural flowing outline. This will facilitate a healthy recovery, any dead, dying and diseased wood will be removed.
3. Hawthorn - This tree has good proportions has does not really require any pruning. No Action
4. Hawthorn - Crown raise to 3m, clear the house by up to 3m, crown reduce by 2m max cut size 50mm
