The tree is a Magnolia Grandiflora which due to its situation requires that it has the crown reduced by 50% and is re-shaped. The tree has not been managed for many years and touches the house on one side; blocking two windows and overhangs the fence on the other. We have been advised by Mr A Wylam, who manages the trees on the West Hill Park Estate.
