Indian Bean Tree (T001) - crown reduction, prune from buildings/structure by 1.0 m - crown is coming into contact with roof line.

Indian bean tree (T007) - raise low canopy to 2.5 m to clear obstruction to highway.

Smooth japanese maple (T008) - crown reduction, prune from building structure by 0.5m - crown coming into contact with front elevation of property.

John Downie (T015) - crown reduction, prune from buildings structure by 0.5m - crown coming into contact with South East corner of adjacent property of no. 2.

Robinia (T022) - remove faulted stems - main tree has previously been felled and new stems are regrowth from stump, with re-growth having an inherent weakness at attachment.
