Informative(s):

1 The application provides notification under Schedule 2, Part 4, Class C of the Town and Country Planning (General Permitted Development) Order 2015 of the intention to use the existing building and any land within its curtilage, known as Jubilee Waterside Centre, as a state-funded school for a single academic year.

A letter has been provided with the application confirming that the Secretary of State for the Department for Education duly notifies the Council, in accordance with Part 4, Class C of the following:

(1) That on 18 August 2015 the Secretary of State approved the site of Jubilee Waterside Centre, 105 Camley Street for use as a state-funded school for the purposes of Class C.2 (a) Part 4 of Schedule 2 of the Order.

(2) That the proposed opening date of Abacus Belsize Primary School from Jubilee Waterside Centre is 1 September 2015.

As referred to in Paragraph C.1, the existing use of the application site is a class of use specified in the Schedule to the Use Classes Order; it does not form part of a military explosives storage area; it does not form part of a safety hazard area; it is not a listed building or a scheduled monument; and the building is not a specified building and the development is not to be undertaken during the specified period (as defined in Paragraph C.3).
