# Statement of Historical Significance

Address: 8-10 Old Square, London, Camden WC2A 3SP

This application relates to the block consisting of 3 properties 8, 9 & 10 Old Square.

#### Condition

The building is in a state of good condition

#### **Asset Assessment**

8-10 Old Square is a Grade 2 listed building constructed in 1774 by Sir George Gilbert Scott. The building is in the Tudor style. Consisting of Red brick outer walls with blue diapers and stone dressings. The roof is pitched covered in Slates with a parapet wall surround. Tall decorative brick chimney pots can be seen protruding through the roof with wrought iron latters and restraints scattered across the roof.

The rear of the building (to which this application relates) faces a sloped bank and has had (until recently) Ivy growing up exterior. The Ivy has been cut back as it was starting to make the walls damp inside and it is proposed to install Wisteria in its place.

#### **Specification**

In order to support wisteria, eyelets and support wires are required. They will be made from Stainless Steel and have a brushed finish to reduce the visual effect caused by the reflective nature of the material. Once the wisteria has grown it will conceal the wires. The wiring layout is shown on the drawings appended to this application.

#### Effect of works to asset

The works will not harm or alter the characteristics of the asset in any way. Eyelets will be installed within mortar joins (opposed to within the brickwork itself) this will mean that any holes could be filled if the eyelets were removed (or replaced) at a later date.

#### Requirement

The works are required to install wisteria which is to replace the Ivy which previously covered the building. This was removed as it had started to damage the building and was becoming difficult to keep in check.

#### **Proposal**

The works are required to support the proposed planting of wisteria. The wiring will enable the existing planted areas to the Northern and Southern Elevations to be joined up along the Western Elevation. This will give continuity to the planting.

It is proposed to plant away from the building by 600mm in order to keep the roots away from the footings. Wisteria Roots are not however perceived as invasive to buildings foundations.
