I wish to object to the above planning application which should be refused for the reasons given below.

I would like to point out that, yet again, No 15 Highgate Rd put a planning application in at a peak holiday time when many residents would be away. Also, that they have ignored conditions imposed on previous development agreements.

It is bad enough that, when the owners first took over the site, they illegally cut down a lovely cherry tree that stood in the forecourt providing an attractive canopy over it and so destroyed an important visual amenity at the corner of Swain's Lane and Highgate Rd. The application to provide cycle and refuse storage at the front adds insult to injury. The owners should not be allowed to make the front area even less attractive than it now is by filling a section of it with bicycle and refuse boxes. The proposed screening shrubs are no substitute for the trees the Council required the owners to plant in a previous planning agreement.
