The trees in our front garden are in need of pruning and, as the property is in a Conservation Area, I understand we need permission to do this. Our tree surgeon plans to do the following work:

56 Eton Avenue Garden area:

Silver Birch general prune

Hawthorn general prune over road area to balance and thin weight.

Sorbus (in side garden) correct imbalanced crown.

Ivy remove and stump poison at base

In addition, the trees in the Garage area next to the house also need attention:

56 Eton Avenue garages 7 x Sycamore to prune height by 25% 3-4metres in length and overhang thin by 30%
