Early mature tree. This tree is starting to block light and outgrow its location. The suggested works are: To reduce the overall height and the lateral spread all round by 1.2-1.5m, thin through the crown by 5%, remove deadwood.

T2 Pittosporum x 1

Dense and widespreading tree. The suggested works are: To reduce the height by 2m, trim all round to shape and contain

Front

T3 Hawthorn x 1

This tree is encroaching on the road and footpath. The suggested works are: To reduce the height and the lateral spread all round by 1.2-1.5m, crown lift to statutory height of 2.5m over the footpath, remove deadwood.

Rear

T4 Fig x 1

Large, dense and widespreading tree. To improve vision and access in the rear garden, the suggested works are: To reduce the height by 2.5m, reduce the lateral spread all round by 1.5m, remove deadwood.
