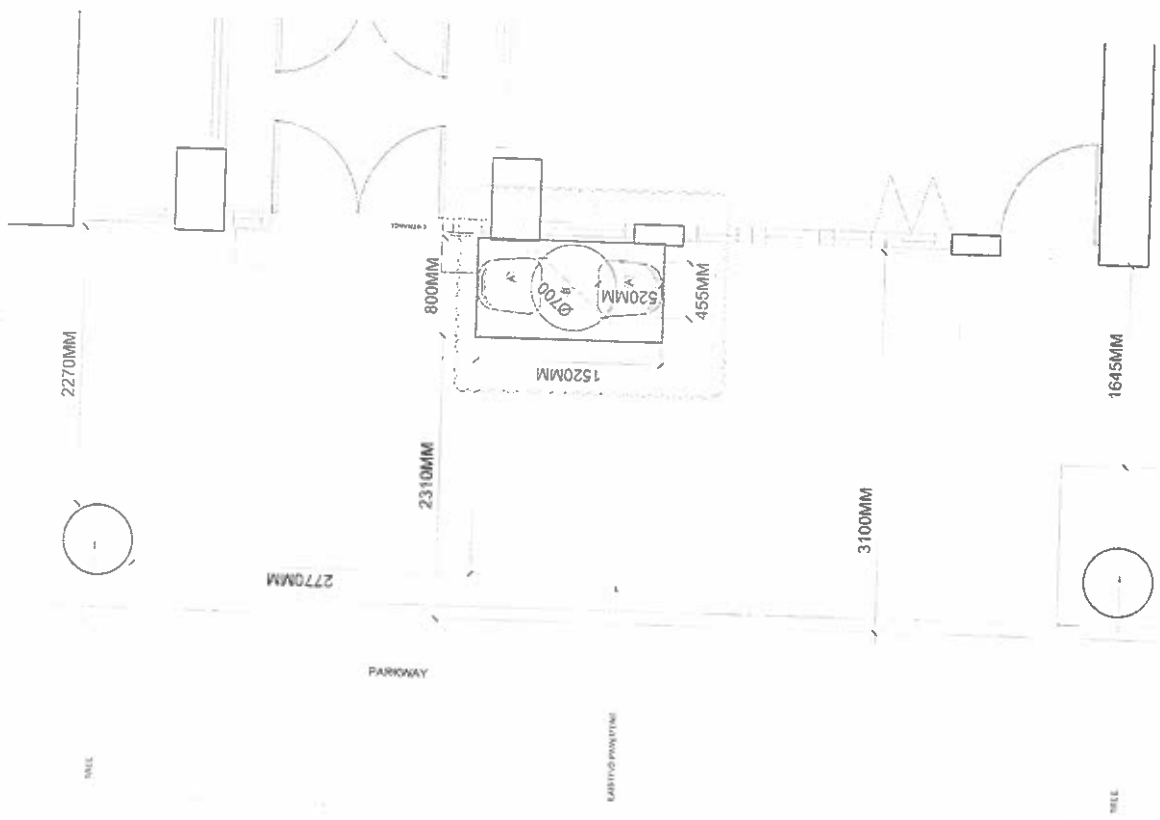
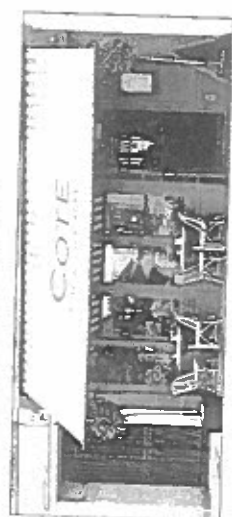
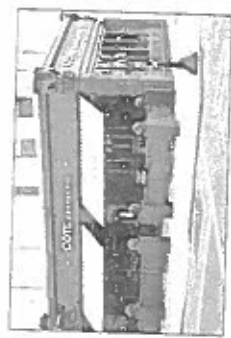

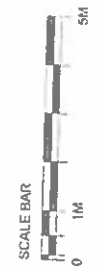


(A) PROPOSED EXTERNAL PLAN
