- 1 Elder.. front left corner.. very large mature tree located in the front left corner of the gardens outside Nos 1-8. trunk expansion and root growth have displaced the boundary wall with No 5 Honeybourne road and the front boundary wall and pillar. To alleviate the problems being caused: fell to ground level by sectional takedown.
- 2 Eucalyptus spp.. rear of 33-40.. Large mature tree very close to the rear elevation of the building. Currently cordoned off. To counter problems and proximity and potential instability: Fell to ground level by sectional take down.
- 3 Ash.. Outside 9-16 front centre.. Large mature old pollard regrown since previous pruning regime. Suggest: to contain spread and maintain structural integrity and improve light and space all round: Repollard to main trunk knuckles.
- 4 Crab apple.. outside 17-24 right side.. Mature tree, not maintained for some time: to contain spread and clearance over garden and pavement and improve light and space all round: reduce and reshape crown by 20-25% all round. Thin and clean out crown, remove deadwood and suckers growth. Lift canopy all round by up to 1m. Balance crown.
