Black Mulberry.

To prune the tree to keep its growth within bounds. The two photos of the tree in full leaf were taken in Sep 2015; that of the bare tree was taken in Jan 2012 immediately after a previous pruning exercise. The intention would be to cut it back to approximately the Jan 2012 configuration (which as you see from its present condition, did the tree no harm). The work would be done in Jan or Feb when the tree is dormant.
