The tree is a mature sycamore located in the rear garden on the boundary with Waterhouse Close.

The work proposed is to carry out substantial groundworks around and within the root system of the tree in order to temporarily support, then remove and rebuild a large retaining wall that supports a much higher ground level where flats just 1m from the wall are located.

A tree protection plan by OMC Associates and all requisite plans from the structural engineer are attached.

The application also includes the reduction in height and radial spread of the crown by 1-8-2.5m with associated "reshaping" and thinning where applicable to compensate for root loss.

The wall is in a state of collapse. This is a combination of age/deterioration and mechanical and quite possibly indirect damage from the sycamore that abuts it.

The proposal is not to remove the sycamore but rebuild the wall and minimize inevitable impact to roots.

A request to reduce the height and radial spread of the crown by 1-8-2.5m with associated "reshaping" and thinning where applicable of the tree is included to compensate for root loss.

Structural engineer drawings and a tree protection plan is attached.
