1 rowen- remove 2 small (2cm dia.) damaged branches at 2m.
2 bay- reduce height by 1m and clip sides hard back
3 cherry-reduce back to previous pruning positions, leaving a natural outline.
4 sycamore saplings (4m)- fell and poison roots.
trees 1 to 4 in rear garden, contact client for access.
5 lime - remove epicormic shoots from trunk up to crown break, remove basal growths
tree 5 is open access in front garden.
