Partially Supressed Purple Plum: Fell to ground level. reason - tree is leaning and located directly beneath canopy of the more significant lime tree.
London Plane: Located in 8 Maresfield Gardens: Approximately 24.00m. Raise crown to main crown break. Reduce back to previous most recent reduction points preserving a small amount of furnishing growth
Yew: Approximately 9.00m. Thin crown density by 20%.
Cherry: Located in 8 Maresfield Gardens: Approximately 14.00m. Reduce crown by 25-30% and thin crown density by 20%. Remove ivy.
Reasons - General maintenance works unless otherwise stated.
