T1 Lime.. Front right, closest to house.. Mature, previously reduced tree. To maintain this tree, the suggested works are: To reduce back to the previous points of reduction, retain shortened furnishing growth for crown continuity, remove deadwood and basal growth.

T2 Lime.. front right.. Larger, previously reduced tree. To maintain this tree, the suggested works are: To reduce back to the previous points of reduction, retain shortened furnishing growth for crown continuity, remove deadwood and basal growth.

T3 Holly.. front. Growing into the lime tree. The suggested works are: To reduce the height by 2-2.5m, prune lateral spread all round to shape and contain.

T4 Sycamore.. front.. Large, mature, previously reduced tree. To maintain the tree, the suggested works are: To reduce back to the previous points of reduction, clean out crown, remove deadwood.

T6 Lawsons cypress.. front.. This tree is too low over the footpath. The suggested works are: To remove x3 low branches over the footpath.

T7 London plane.. rear adjacent to garage.. Extra large, mature, widespreading tree. To allow more light through, provide clearance from the property and to reduce the overall moisture uptake. The suggested works are: To Reduce back upper crown from roof, gutters and side elevation of No 40 to give 2-3m clearance. Lift canopy all round and especially over the road by 3m to improve clearance and light and space. Clean out crown, remove deadwood, weak, suppressed and crossing branches, thin through the crown by 5%.

T8 Lime Rear.. Large, mature tree. This tree is overhanging the garden and the pool. The suggested works are: To reduce the overhanging lateral spread back to the previous points of reduction.

T9 Cypress. rear.. Prune back lateral spread over the garden by 1m to improve access in the garden.

T10 Lime.. rear right hand corner.. Large, mature, previously reduced tree. To maintain the tree, the suggested works are: To reduce back to the previous points of reduction, retain shortened furnishing growth for crown continuity, remove deadwood.
