T1 Pittosporum. rear left.. This tree is encroaching on the house. The suggested works are: To reduce the height and the lateral spread all round by up to 1.5m to shape and contain.

T2 Apple.. rear left.. Large, mature tree. This tree is looking a bit sparse and unhappy. This is most likely to be drought stress, there were no signs of fungal fruiting bodies at the time of the inspection. To re-invigorate the crown, the suggested works are: To reduce the overall height and the lateral spread all round by 2.5-3m, clean out crown, remove deadwood.

T3 Rear left.. Growing into the Apple tree. The tree also has a common plum sucker coming off of the grafted root stock. The suggested works are: To prune back from the Apple by 1m, remove the root sucker.
