Tree of Heaven T1 22 M high / 700mm dia - large wide-spreading tree with large deadwood present in small courtyard. Remove very low basal branch back to stem, remove all deadwood and reduce crown by 2 metres on sides only.

Holly T2 - 10M high / 175mm dia - very close to buildings - reduce height down to 6M and draw in sides all around by 1/2 to 1 M

Elder T3 - 5M high / 4 x 175mm stems - poor condition and suppressed by T1 - scaffold pollard down to 6 M and allow to re-grow
